Background

Americans with Disabilities Act (ADA) Legislation

ADA was signed into law Jan. 26, 1990 and became effective Jan. 26, 1992. ADA makes discriminating against people with disabilities unlawful.

ADA comprises several sections of the United States Code compiled into five subject areas referred to as titles:

- Employment (Title I).
- Public services (Title II).
- Public accommodations and services operated by private entities (Title III).
- Telecommunications (Title IV).
- Miscellaneous (Title V).

Title II has the broadest impact on the Kansas Department of Wildlife, Parks & Tourism (KDWPT), as it specifically covers programs, services, or activities relating to areas of public services and updating existing infrastructure. Title II requires KDWPT to develop a transition plan to bring applicable facilities into compliance with ADA. This document presents the transition plan the KDWPT has developed for public access facilities within KDWPT jurisdiction.

Title II of ADA

Title II places emphasis on the accessibility of infrastructure within public access areas. In order to achieve accessibility and consistency, public agencies are required to modify their policies, practices, and procedures to avoid discrimination without altering the fundamental nature of services, programs, or activities. Facilities required to be ADA compliant include the areas of:

Physical Barriers:

- Parking areas & Ramps
- Areas of Service Paths of Entry & Travel
- Doorways
- Restrooms
- Service Counters

Programmatic Barriers:

- Building signage
- Customer communications and interaction
- Access to public telephones (where applicable)
- Emergency Notifications, alarms, and visible signals (where applicable)
- Participation opportunities for KDWPT sponsored events (where applicable)

KDWPT facilities, programs, services, policies, practices and procedures will continue to be surveyed on an on-going basis, and the Plan may be revised from time to time to account for changes to KDWPT activities. An accessibility of inventory applicable items is being updated and an approach put in place to ensure that all barriers are being addressed. This Plan has been posted to KDWPT's web site for review and consideration by the general public. Any individual may submit comments on the accessibility of KDWPT programs and facilities by contacting the Agency's ADA Coordinator, or his/her designee by phone at (785) 296-2281.

Defining ADA Compliance

Buildings will be considered ADA compliant when they meet the criteria outlined in the "U.S. Department of Justice's ADA Standards for Accessible Design" (2010)

Agencies Affected

All state and local governments are required to prepare a self-evaluation of all roadways and pedestrian facilities within their jurisdiction. In addition, all local governments with more than 50 public employees are required to develop a transition plan for all noncompliant facilities.

Because the number of employees can fluctuate from year to year, KDWPT researched to determine the average population associated with 50 city employees. The research determined, generally, cities in Kansas with more than 5,000 people had more than 50 city employees and should have their own transition plans.

Some of the pedestrian features located on KDWPT areas of access are owned and maintained by other Jurisdictions. To avoid conflicts that may arise with other jurisdictions' transition plans, KDWPT has elected to defer to those jurisdictions' transition plans in areas of joint jurisdiction rather than producing duplicate plans for those areas. KDWPT's transition plan will focus on areas without joint jurisdiction.

ADA Transition Plan

The purpose of the transition plan is to identify the steps KDWPT will take to achieve ADA compliance for applicable facilities. These steps are:

- 1. Identify physical obstacles limiting the accessibility of programs or activities to individuals with disabilities.
- 2. Identify KDWPT's ADA coordinator who will be responsible for ADA compliance.
- 3. Describe in detail the methods that will be used to make facilities accessible This detailed information is available upon request by contacting the KDWPT ADA Coordinator, Chad Depperschmidt
- 4. Develop a Schedule for achieving compliance.
- 5. Develop a grievance procedure to review complaints.

The first 4 steps are the minimum requirements for a transition plan as set forth by 28 CFR 35.150

The remaining steps are additional requirements for achieving ADA compliance as set forth by Title II.

In addition to the above steps, KDWPT will monitor and report on their compliance progress as necessary.

To ensure ongoing compliance with ADA requirements, KDWPT will perform periodic reviews of the plan and update as necessary. As a part of ongoing updates to the ADA Transition Plan, KDWPT will continue to allow public comment and input and provide a continuing opportunity for interested parties to participate in development of their transition plan.

ADA Coordinator

Chad Depperschmidt, KDWPT's Budget Director/Land Acquisitions is responsible for the implementation of KDWPT Transition Plan, as the ADA Coordinator and the Administrator of the ADA Program.

The ADA Coordinator is responsible to coordinate and monitor the progress of the ADA Program; however, many throughout KDWPT contribute to the overall ADA compliance process.

Public Involvement

In approximately 1993 it was indicated KDWPT included disability advocates in development of the original plan. Such advocates included disability advocacy groups in various cities in Kansas.

Notification that changes have been made to the KDWPT ADA Transition Plan and are available for public comment will be made through social media which can include but is not limited to Facebook and Twitter. Comments can always be made by accessing KDWPT's website and submitting comments as outlined on the following pages of this ADA Transition Plan.

KDWPT will adopt and publish procedures for resolving complaints arising under ADA's Title II. The procedures are intended to set up a system for resolving complaints of disability discrimination in a prompt and fair manner. The next section provides the process and the form used to review complaints.

State of Kansas Grievance Procedure under The Americans with Disabilities Act

This Grievance Procedure is established to meet the requirements of the Americans with Disabilities Act of 1990 ("ADA"). It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in the provision of services, activities, or programs by the Kansas Department Wildlife, Parks, & Tourism (KDWPT).

The complaint should be in writing and contain information about the alleged discrimination such as the name, address, and phone number of complainant and location, date, and description of the problem. Alternative means of filing complaints will be made available for persons with disabilities upon request.

The complaint should be submitted by the grievant and/or his/her designee no later than 60 calendar days after the alleged violation to:

Within 15 calendar days after receipt of the complaint, KDWPT's ADA Coordinator or designee will meet with the complainant to discuss the complaint and the possible resolutions. Within 15 calendar days of the meeting, ADA Coordinator or designee will respond in writing, and where appropriate, in a format accessible to the complainant.

The response will explain the position of the Kansas Department of Wildlife Parks & Tourism and offer options for resolution of the complaint.

All complaints received by the ADA Coordinator will be retained by KDWPT for at least three years.

Additionally, interested persons, including individuals with disabilities or organizations representing individuals are encouraged to submit comments on KDWPT's ADA Transition Plan in writing to the ADA Coordinator utilizing the Grievance/Comment Form.



Grievance/Comment Form Public Accommodations

This form shall be used by anyone wishing to submit comments or file a grievance alleging discrimination on the basis of disability in the provision of services, activities, programs or benefits by the Kansas Department Wildlife, Parks & Tourism (KDWPT). This form should be submitted no later than **60 calendar days** after the alleged violation to:

Alternate means of filing complaints will be made available upon request. Within 15 calendar days after receipt of the complaint the ADA Coordinator, or his designee will meet with the complainant to discuss a possible resolution. A written response will be provided to the complainant with 15 days of meeting.

NOTICE UNDER THE AMERICANS WITH DISABILITIES ACT

In accordance with the requirements of title II of the Americans with Disabilities Act of 1990 ("ADA"), the Kansas Department of Wildlife, Parks & Tourism (KDWPT) will not discriminate against qualified individuals with disabilities on the basis of disability in its services, programs, or activities.

Employment: KDWPT does not discriminate on the basis of disability in its hiring or employment practices and complies with all regulations promulgated by the U.S. Equal Employment Opportunity Commission under title I of the ADA.

Effective Communication: KDWPT will generally, upon request, provide appropriate aids and services leading to effective communication for qualified persons with disabilities so they can participate equally in KDWPT programs, services, and activities, including qualified sign language interpreters, documents in Braille, and other ways of making information and communications accessible to people who have speech, hearing, or vision impairments.

Modifications to Policies and Procedures: KDWPT will make all reasonable modifications to policies and programs to ensure that people with disabilities have an equal opportunity to enjoy all its programs, services, and activities. For example, individuals with service animals are welcomed in KDWPT offices, even where pets are generally prohibited.

Anyone who requires an auxiliary aid or service for effective communication, or a modification of policies or procedures to participate in a program, service, or activity of KDWPT should contact the office of Chad Depperschmidt, ADA Coordinator, (785)296-2281 as soon as possible but no later than 48 hours before the scheduled event.

The ADA does not require the KDWPT to take any action that it can demonstrate would fundamentally alter the nature of its programs or services, impose an undue financial or administrative burden, or take any action that would threaten or destroy the historic significance of a historic property.

Complaints that a program, service, or activity of KDWPT is not accessible to persons with disabilities should be directed to Chad Depperschmidt, ADA Coordinator, (785)296-2281.

KDWPT will not place a surcharge on a particular individual with a disability or any group of individuals with disabilities to cover the cost of providing auxiliary aids/services or reasonable modifications of policy, such as retrieving items from locations that are open to the public but are not accessible to persons who use wheelchairs.

Featured Inventory

The next section is devoted to KDWPT's inventory of owned facilities. The general information has been collected and is listed in Appendix A. Appendix A indicates inventory item status and the intended plan of action where applicable.

Types of facilities open to the public may include the following:

- Administration Buildings
- Regional Offices
- Park, Public Land & Wildlife Offices
- Shelters & Restrooms

Building & Structure Inventory ADA Plan

The inventory of occupied buildings, and structures which are available for public services and programs is attached for the purpose of this transition plan. KDWPT manages a number of buildings and structures that are not deemed for public service or public access. For information on those facilities, please contact the KDWPT ADA coordinator. For those buildings/structures where public services are provided, we have worked for several years to make them ADA compliant.

Each facility is denoted with a rating code.

Rating Code

- O Site is not accessible undue burden to achieve accessibility
- 1 Site is accessible, but structure cannot be retrofitted, needs new structure
- 2 Facility or Structure can be made compliant with extensive remodeling
- 3 Facility or Structure can be made compliant with minimal effort and cost
- 4 In full compliance or requires only minor adjustments

From 2019 forward it is the intention of KDWPT is to fully upgrade all facilities and structures listed in the plan which are not fully ADA compliant as financing allows. KDWPT has a building program underway that is modernizing public access and non-public use facilities/structures and bringing the office and shop portions of the building up to ADA standards. KDWPT has improved a number of these and, as funds allow, intend to upgrade/improve some of the facilities/structures each year, as well as those which are slated for replacement.

It is the desire of the Kansas Department of Wildlife, Parks and Tourism to continually update ADA compliance and copies of the departments non-discrimination, sample accessibility, effective communication and website accessibility checklists are available by contacting KDWPT's ADA Coordinator.

It is noted there is no "grandfather" clause in the ADA, and governments must comply with Title II of the ADA, and must provide program access for people with disabilities to the whole range of services and programs. In providing program

access city governments are not required to take any action that would result in a fundamental alteration to the nature of the service, program, or activity in question, that would result in undue financial and administrative burdens or take any action that would threaten or destroy the historic significance of a historic property.

If an action would result in such an alteration or such burdens, a government must take any other action that it can to ensure that people with disabilities receive the benefits and services of the program or activity. 28 C.F.R. § 35.150(a)(3). Those structures with no ability to be fully upgraded will be included various programs designed to assist those persons in need of services provided by the individual facility based on individual facility/structure needs.

Index A represent the most current compiled Inventory Status and indicated plan of action where applicable. Where status or plan of action is not indicated, the most recent status can be provided KDWPT's ADA Coordinator.
